



**Alternate Transportation Consent and Release**

New Caney Independent School District (“NCISD”) provides transportation to and from NCISD athletic events for students participating in school-sponsored activities. If the parent, guardian, or student if eighteen (18) years-old or older, wishes to arrange alternative transportation for the student other than the transportation provided by NCISD, the parent, guardian, or student if eighteen (18) years-old or older, signing below assumes full responsibility for the student’s alternative transportation. Alternative transportation includes, but is not limited to, transportation provided by the student’s parent or guardian, transportation provided by the parent or guardian of another student or any other third party, or any other form of transportation other than the transportation provided by NCISD.

The parent, guardian, and student if eighteen (18) years-old or older, understands that alternative transportation entails foreseen and unforeseen risks, which may result in minor or severe injury or damage, including, but not limited to: bodily injury, emotional distress, death, and/or property damage to the student and/or third parties. The parent, guardian, and student hereby and forever fully and unconditionally waive and release, and hold harmless NCISD, its trustees, agents, employees, officers, volunteers, representatives, affiliates, successors, and assigns, jointly and severally, from any and all liability, claims, demands, and causes of action, known or unknown, in law and in equity, for physical or emotional injury, property damage, or death, including wrongful death, that the student may cause and/or suffer which are in any way connected with, arising out of, or resulting from the student’s alternative transportation to and from NCISD’s school-sponsored activities.
